Superior innovation ranking across entire Cloud technology space: Techlnsights evaluated the U.S. patent portfolios of Microsoft, Microsoft Azure IP Advantage, IBM, Oracle, Google, VMware and Amazon based on their share of key foundational Cloud technology patents. Techlnsights ranks the full Microsoft portfolio first in innovation and found that the Microsoft Azure IP Advantage portfolio holds its own against leading competitors in the Cloud patent ranking.

Quality and strength consistent with Microsoft's whole world class portfolio: Microsoft's portfolio has more than 60,000 patents and is ranked as one of the top in the industry. TechInsights compared the patent landscape of all currently active Microsoft patents with those available in the Microsoft Azure IP Advantage offering and found that the Microsoft Azure IP Advantage patents accurately reflect the full scope of quality and diversity and technology coverage of the whole Microsoft portfolio. There are no significant gaps in coverage.

Using TechInsights' IP analytics solutions a preliminary group of 7,500 patent assets was assessed, including 4,100 US grants and 100 US applications provided by Microsoft and considered to be representative of the final Azure IP Advantage portfolio. This portfolio was analyzed based on seven factors: Azure IP Advantage composition and comparison to overall Microsoft portfolio; patent age; forward references; comparison to previously litigated patents on Cloud; innovation comparison with five top Cloud market competitors; global coverage; and likelihood of use.
